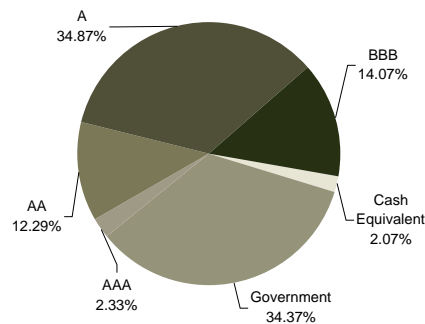
WHO SHOULD INVEST
